



DANCESPORT NEW ZEALAND NOMINATION FORM FOR A WORLD DANCESPORT FEDERATION ADJUDICATOR LICENCE

DanceSport New Zealand (DNZ), a full member of the World DanceSport Federation (WDSF), is responsible for nominating individuals who wish to become a WDSF Adjudicator for New Zealand.

REQUIREMENTS:

Persons wishing to apply for nomination for a WDSF Adjudicator Licence must:

- 1) Complete this application form and acknowledge its requirements by signing the declaration.
- 2) Hold and provide a copy of a current DNZ Adjudicator Licence.
- 3) Be over 18 years of age.
- 4) Provide two confidential independent character references *(These must be written and sent by your referees directly to the DNZ Sport Officer)*.
- 5) Be of good character, have good standing in the New Zealand dancesport community, reputable, ethical and highly regarded as an adjudicator by your peers.
- 6) Acknowledge the role of DNZ in New Zealand dancesport by proactively supporting the activities of DNZ and its obligations to membership of other bodies (ie WDSF & New Zealand Olympic Committee).
- 7) Hold a national adjudication qualification or international equivalent in Latin and Standard styles.
- 8) Pay the licence fee of NZ\$200 and a non-refundable application fee of NZ\$75 (Fees are reviewable regularly).
- 9) Not be a national adjudicator for any other WDSF member body.
- 10) Satisfy at least one of the following:
 - a) hold New Zealand residency,
 - b) be a New Zealand citizen, **or**
 - c) be domiciled in New Zealand.

In addition to the requirements 1 to 10 (above), to comply with WDSF Adjudication regulations, applicants must fulfil the following requirements:

- 11) Provide a Curriculum Vitae (CV) including:
 - (i) formal education,
 - (ii) dance experience *(as competitor, trainer, adjudicator, lecturer etc)*, and
 - (iii) dance education *(examinations, seminars, congresses)*.
- 12) Provide a copy of technical exam papers in Latin and Standard, clearly identifying the examining organisation and the name of the examiner *(refer item 6)*.
- 13) Have held a DNZ national adjudicator licence for a minimum of two (2) years.
- 14) Attend two WDSF congresses and pass any relevant assessments, as specified by the WDSF.
- 15) Agree to abide by the WDSF Adjudicators Code of Conduct and Standards of Ethics.
- 16) Support the goals and objectives of WDSF.

APPLICATION PROCESS:

- 1) Applications should be submitted to the DNZ Sports Officer. Once complete, applications will be considered at the next DNZ delegates' meeting.
- 2) DNZ decision is to be by a seventy five percent majority in favour of the applicant.
- 3) Where the application is approved by DNZ, the necessary formal nomination will be made to the WDSF for checking and registration as a WDSF Adjudicator.
- 4) Any application which is not accepted will be returned to the applicant with the relevant documentation and licence fee.

Any breach of conditions may result in suspension or non-renewal of licence.

- I agree to the terms of the WDSF Anti Doping Code, WDSF Competition Rules, WDSF Code of Conduct and Standards of Ethics and am aware that if I violate any of these codes and rules that I may be subject to disciplinary sanctions as set out in the respective code or rules.
- I confirm that copies of the respective documents have been made available to me.
- I understand that failing to meet the renewal criteria and payment of the licence fee by 1 November will mean that my licence will be suspended and may not be renewed.
- I agree to provide notice to the DNZ Sports Officer of any invitation or offer to adjudicate at a WDSF event and will not accept any invitation or offer until I have received a written acknowledgement of the notice.
- I agree to provide a written report to the DNZ Sports Officer within one month of any WDSF event at which I adjudicate and understand that part or all of this report may be published at the discretion of DNZ.
- I agree to and will comply with all other conditions as specified in the Requirements provided with this nomination and all future amendments including any replacement rules and regulations issued from time to time by DNZ.
- I understand on being accepted for a WDSF Adjudicator Licence that the information in this application will be made available to the WDSF for checking and registration as a WDSF Adjudicator.
- I recognize the authority of DNZ and that its decision is final and binding.
- I accept there is no right of appeal and that I may not reapply until a period of two years has elapsed.
- I agree that my personal details may be disclosed to the New Zealand Police for vetting at least every five years following issue of the WDSF Adjudicator licence.
- I am aware that any breaches of the above conditions may result in the non-renewal of the WDSF Adjudicator Licence and suspension as a WDSF Adjudicator.
